Ms. Palacio:

You have inquired regarding whether, given your current position as Special Projects Administrator for the Miami-Dade County Public Works and Waste Management Department you may represent a private law client as a private attorney before the Miami-Dade County Commission on Human Rights.

Please be advised that under Section 2-11.1(m)(1), no County employee "shall appear before any County board or agency and make a presentation on behalf of a third person with respect to any license, contract, certificate, ruling, decision, opinion, rate schedule, franchise, or benefit sought by the third person. Nor shall such person receive compensation, directly or indirectly or in any form, for services rendered to a third person, who has applied for or is seeking some benefit from the County or a County agency, in connection with the particular benefit sought by the third

person. Nor shall such person appear in any court or before any administrative tribunal as counsel or legal advisor to a party who seeks legal relief from the County or a County agency through the suit in question.”

Since you are a County employee and the Miami-Dade Commission on Human Rights is a County board, you may not represent a client on a matter pending before that board.
