Councilman DeFillipo:

You have inquired regarding whether you have a voting conflict, which is governed by Miami-Dade County Code Section 2-11.1(d), in connection with an anticipated vote on a towing RFP coming before the North Miami Beach City Council. Your father owns the land on which one of the bidding companies, Downtown Towing, leases land for the storage of cars. Neither you nor your father has a financial interest in Downtown Towing, and you personally have no financial interest in the land that is used by Downtown Towing. Downtown Towing is one of a number of companies bidding on the contract, and several companies are expected to be chosen to contract with the City of North Miami Beach to provide towing services services under this RFP. Downtown Towing is a company that provides towing services in areas outside of North Miami Beach, and maintains other site locations outside of the City to store the vehicles of which it takes possession.

Under these circumstances, I do not find that you have a voting conflict in this matter. You do not have any of the specified relationships with Downtown Towing that under Section 2-11.1(d) might create a conflict of interest. Also, you do not stand to profit or be enhanced personally by the vote on this matter. Neither you nor your father have a financial interest in Downtown Towing that would trigger the prohibition on participation in an official action under Section 2-11.1(n). Accordingly, you may participate and vote on this matter.
