Eddie:

You have inquired regarding whether the incentives offered by the Dade County Bar Association for early membership renewal, termed "Bar Bucks," raise any issues or concerns under the Miami-Dade County Ethics Ordinance, specifically, Section 2-11.1(e) of that ordinance. Based on the information you have provided, the "Bar Bucks" have no cash value, and are usable for discounts at certain bar-sponsored events for which there is a charge. They are available to all present and prospective members of the Bar Association, which include private and public sector lawyers, and are in no way targeted to County employees or other public employees. The consideration for the transfer is the early payment of bar dues for renewing members or the early payment of membership fees by new members.

Based upon the available information, it is my opinion that the incentives labeled "Bar Bucks" do not constitute a gift under Section 2-11.1(e), insofar as there is an adequate and lawful consideration provided by the recipient to the Bar Association in exchange for the benefit in the form of early payment of bar dues or membership fees. The uniform provision of the benefit to all of those who qualify does not indicate any intention of providing any individual with a gift since everyone is eligible to qualify for the benefit.
