Ms. Green:

Overtly political emails should not originate from County computers or from any governmental source. Many political emails, including fundraising requests, are often sent from private sources to governmental email addresses, which can be obtained as public records. I have generally advised people in local government to refrain from responding to such emails to avoid any perception that they may be utilizing government property for political purposes. Such activity could be considered to be a violation of Section 2-11.1(g) of the County Ethics Code, which prohibits exploitation of one's public position. Either deleting such emails or responding by informing the sender that you do not wish to receive such emails in the future would be appropriate.
