You have inquired regarding whether members of the Town of Miami Lakes Charter Review Committee are required to file annual financial disclosure under Section 2-11.1(i) of the Miami-Dade Conflict of Interest and Code of Ethics Ordinance. Based on prior COE opinions, members of a Charter Review Committee in existence for less than one year would not be required to file financial disclosure under the County Ordinance. They would, however, be subject to the other provisions of the Miami-Dade Code of Ethics, as well as the State of Florida Code of Ethics pursuant to Section 17 of Town of Miami Lakes Resolution No. 15-1291.
