Robert Meyers, Esq., of Weiss Serota Helfman Cole Bierman, P.L., a firm that represents several municipalities in the County, inquired concerning whether it would be necessary for a City Manager in a municipality to report as outside employment his reactivating of his contracting license in order to close out some expired permits that needed to be closed and on which the individual had previously done work and been paid. This person was hired as City Manager on the condition that he would close out his private business as a roofing contractor, which he had done. These matters were brought to his attention following the lapse of his contractor's license. They involve work for which he was previously paid, and he will receive no further compensation for the closing out of the permits. I advised that since the services he will be performing involve private work for which he has been compensated, even though the compensation preceded his public employment as City Manager, he should disclose the work as outside employment, following his obtaining approval from the governing body for his reactivation of his license solely for that purpose.
