Ms. Webb:

You have inquired on behalf of PortMiami Director and CEO Juan Kuryla and Deputy Port Director Kevin Lynskey concerning whether they may accept the invitation of Norwegian Cruise Line, a county contractor, to attend the inaugural ceremonies for their newest vessel, Norwegian Joy, which will take place in June in Shanghai, China. They have been invited by the company to this christening event, which will include on-board inaugural festivities as well as a cruise to ports in China.

As has been the case in the past with similar events, the Port is aware of the restrictions in Section 2-11.1(w) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, under which no County official or employee may accept any paid travel or travel-related expense from a County contractor or service provider. Travel-related expenses may include food, lodging, registration fees and incidentals in addition to actual transportation expenses.

It is my understanding, based on information provided by you, that the County will be paying all expenses for this trip, including airfare, lodging, meals, etc. Additionally, the County will receive a bill for the cabin space utilized on this trip by Mr. Kuryla and Mr. Lynskey, and pay that expense out of County funds. Due to these arrangements, I see no prohibition under Section 2-11.1(w) that would prevent Mr. Kuryla and Mr. Lynskey from attending this event. It will serve a public purpose in that it is clearly related to the County's interest in a continuing productive relationship with an important County business partner. It is also my understanding that, while in China, these Port officials will be attending to other Port business in visiting and interacting with another Port client.

Additionally, I do not see any problem with their attending on-board receptions that may be sponsored by the Cruise Line where their presence is warranted based upon their public positions with PortMiami and their participation in the event is based on their public positions at PortMiami.
