Mr. Fernandez:

You have inquired on behalf of Miami-Dade County Commissioner Rebeca Sosa (DIST 6) regarding whether she would have a voting conflict of interest on Item 2C(171452), currently before the Transportation and Public Works Committee of the BCC.

This inquiry is made in light of Commissioner Sosa's full-time employment with the Miami-Dade Public Schools as a curriculum specialist at the Lindsey-Hopkins Center. The issue under consideration deals with directing the County Mayor to analyze the potential benefit of allowing school buses by the Miami-Dade County Public Schools to use the South Dade Transitway while transporting children to and from school or school-related events.

In the past this agency has opined that Commissioner Sosa's employment by a government agency does not automatically disqualify her from voting on a matter affecting her employer under Section 2-11.1(d) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance. (See, e.g., INQ 17-126). In addition, I see no basis on which to conclude that Commissioner Sosa would personally profit or be enhanced by the action taken on this item. Therefore, I have concluded that she does not have a voting conflict of interest on this issue, and that she may participate and vote on it.

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO ANALYZE THE POTENTIAL BENEFITS OF ALLOWING SCHOOL BUSES OPERATED BY THE MIAMI-DADE COUNTY PUBLIC SCHOOLS DEPARTMENT OF TRANSPORTATION TO USE THE SOUTH DADE TRANSITWAY WHILE ENGAGED IN THE TRANSPORTATION OF CHILDREN TO AND FROM SCHOOL OR SCHOOL-RELATED EVENTS, AND TO PROVIDE A REPORT TO THE BOARD WITHIN SPECIFIED TIME PERIOD

WHEREAS, the South Dade Transitway is a dedicated lane for transit service from Dadeland South Metrorail Station to S.W. 344th Street; and

WHEREAS, southern Miami-Dade County experiences high traffic congestion, particularly during peak traffic hours; and

WHEREAS, the peak traffic hours, predominantly in the morning hours, overlap with school hours; and

WHEREAS, allowing school buses to operate on the South Dade Transitway may reduce traffic congestion in the areas generally surrounding the South Dade Transitway and could also result in greater mobility for those vehicles that transport children to and from school and school-related events,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee to analyze the potential benefits of allowing school buses operated by the Miami-Dade County Public Schools Department of Transportation to use the South Dade Transitway while engaged in the

transportation of children to and from school or school-related events. The analysis should include, but should not be limited to, identifying the number of daily school bus trips on average that could potentially benefit from having access to the South Dade Transitway, assessing any potential benefits and challenges to the operation of the busway as an integrated facility that allows school bus use, and assessing whether allowing school buses on the South Dade Transitway would result in a reduction of traffic congestion. The analysis should also be completed in consultation with Miami-Dade Public Schools and applicable federal and state agencies.

Section 2. Directs the County Mayor or County Mayor's designee to provide a report regarding the study identified in Section 1 above to the Board within 120 days of the effective date of this resolution and place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.
