Section 2-11.1(w) of the Conflict of Interest and Code of Ethics ordinance **prohibits** you from accepting, directly or indirectly, **any travel expenses, lodging, meals, registration fees and incidentals** from any County contractor, vendor, service provider, bidder or proposer.

The prohibition may only be waived by a majority vote of the Board of County Commissioners. Reference is made to INQ16-200 and INQ 13-26.
