Mr. Kosoko,

I am in receipt of the attached memo issued based upon the background investigation of selection committee members for RFP No. MDAD 11-16, done pursuant to BCC Resolution No. R-449-14. One of those selection committee members, Lazaro "Ray" Diaz, an MDAD employee, indicated on his disclosure form that he oversees SP Plus Corporation, which includes SP+ Corporation, a respondent on this project. Mr. Diaz oversees SP Plus Corporation, which has an agreement to operate parking at MIA.

It is my opinion that Mr. Diaz does not have any voting conflict of interest under Section 2-11.1(v) of the County Ethics Code that would prohibit him from voting on or otherwise participating in this committee. He has no prohibited relationship with the respondent corporation, nor would he be personally or directly affected by the procurement decision.

Moreover, I do not think that his familiarity with parent corporation of the respondent company would in any way interfere with his objective and independent judgment in the selection process. Mr. Diaz has personally assured me that he believes he can be completely fair. It is often appropriate that persons who make procurement decisions on behalf of the County have some personal knowledge of one or more of the respondents through their County employment duties. Having such a perspective adds depth and knowledge to the committee. Mr. Diaz has assured me that he has no personal friendships or relationships with persons at the respondent company that would prevent him from exercising his best judgement for the benefit of the County.

Accordingly, I believe that Mr. Diaz is an appropriate person to serve on the committee.
