Lydia Lopez, Assistant to Senior Advisor Michael Spring, Office of the Mayor, Miami-Dade County, inquired concerning whether Mr. Spring, as well as Deputy Mayor Ed Marquez, who were both appointed to the Frost Museum of Science Board to represent the County's interests, would need to disclose their County employment on a form generated by the Frost Museum Conflict of Interest Policy, due to their employment in an organization that might benefit from an action of the board. I informed Ms. Spring that, since they were appointed to the board explicitly as County representatives, and because the board oversees an operation with which the County has many mutual and supportive interests and is essentially partner, that they would not need to list such employment. Such disclosure is obviously geared to the disclosure of possible conflicting interests with the Frost Museum, that could amount to voting conflicts or other significant conflicts, regarding which the Museum board and management should be aware. The explicit appointment of County personnel to represent the County's interests on a board with which the County is engaged primarily on matters of community and County interest, would indicate that their representation of the County on this board, by itself, could not create a conflict of interest with the board. I advised that it was my opinion that they need to disclose their County employment as it was already disclosed by virtue of their appointments and did not create a conflict of interest with disclosure form.
