### Dear Mr. Cornejo,

You inquire whether you are required to pay the lobbyist registration fee and complete the ethics training as an employee of Raymond Jungles, Inc. when representing the private, for-profit company and speaking on its behalf before the County Commission.

Pursuant to our conversation, you have advised that you have indeed registered, paid the fee and you will be participating in the ethics training. As I explained to you, the lobbyist registration requirements apply to a principal and any person employed or retained by a principal (in this instance, Raymond Jungles, Inc. is the principal) who seeks to encourage the passing, defeat or modification of an ordinance, resolution, action or decision of the County Commission, County Mayor, County board or committee. All lobbyists must register with the Clerk of the Board, pay the registration fee, pay and complete the ethics course. *See* Section 2-11.1(s), County Ethics Code.

There is an exemption of the lobbyist registration **fee** for *principals* of a corporation, however, principals are still required to register and take the ethics course if they are going to lobby. The following individuals are considered *principals*: the president, owner or chief shareholder of the corporation who engages in lobbying; an individual who has been designated by the corporation or who has the apparent authority to make final decisions on behalf of the corporation who engages in lobbying; or, a member of the corporate board who has been appointed as the representative during lobbying activities. In these instances, the *principal* is required to complete the lobbyist registration and take the ethics course, but he or she is exempt from the registration fee. *See* Section 2-11.1(s)(3)(b); RQO 10-09; INQ 15-190. Consequently, if you have been designated by your employer as the *principal* of the corporation, you should seek reimbursement of the lobbyist registration fee. Otherwise, if you will engage in lobbying on behalf of the corporation, the most prudent course of action is to register, pay the fee and sign up and pay for the ethics course, as you did.
