Liz,

The Miami-Dade Commission on Ethics has never dealt specifically with this question. We have, however, opined on the question of whether it is improper for elected officials to hear items presented to their boards/commissions by their relatives (generally in situations where the relative is representing a third-party client). According to the county's Conflict of Interest and Code of Ethics Ordinance, there is no outright prohibition against such an appointment. I can certainly understand why this would make you feel uncomfortable. Our office on many occasions has cautioned requesters against engaging in conduct that might create "appearance" problems, but, as you know, it is outside our authority to render opinions based on perceptions.
