Robert:

I assume that it is your call whether R-340-03 exempts Dial-a-Life Board members from the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance. Let me know if you believe that this issue is in your jurisdiction. It appears to me that section 2-11.39.2, Miami-Dade County Code authorizes the Commission to exempt boards by resolution and that the Resolution at issue does exempt Dial-a-Life board members. In case you need this information, the Dial-a-Life Board is created by section 2-1311, Miami-Dade County Code.

A second issue is whether Dial-a-Life Board members must file financial disclosure pursuant to state statute. Section 112.3145 of Florida Statutes does not include advisory boards in the definition of "local officers" that must file financial disclosure under State law. Thus, it appears that Dial-a-Life members are not required by State law to file financial disclosure. Let me know if your office has an opinion on this issue as well.
