Ms. Russell,

Thank you for the additional information. Based on what you have provided, I can issue an opinion. As I understand it, you have an employee who sits on the Planning Council for the city of Opa-Locka and a company that your non-profit wishes to solicit for summer field trips has a matter before the Planning Council. You further explain that employee will not be involved in the solicitation efforts. You wish to know whether a conflict of interest is created if your employee participates as a member of the Planning Council in a decision that will affect this company if your non-profit solicits this company.

Under the county's Conflict of Interest and Code of Ethics Ordinance, a conflict would be created if your employee promised the company favorable consideration by the Planning Council in return for a donation to non-profit's summer field trip program. Assuming such conduct is not going to transpire, I find that no violation of the ethics code exists if your employee participates in the Planning Council agenda item involving the company that your organization is planning to solicit as long as the employee plays no role in any solicitation efforts with respect to the company.
