Ms. Robinson,

Thanks for the reminder. I was on vacation all of last week. This is to confirm that we had a conversation about sitting on a County board and a municipal board simultaneously. There is no provision in the county's Conflict of Interest and Code of Ethics Ordinance that would prohibit you from being a member of the Miami-Dade HIV/AIDS Partnership and at the same time serving as a member of the Model City Trust Advisory Board.

As far as bidding on County or City work is concerned, there are a few restrictions that may apply. Your company is not permitted to enter into a contract with the County or the City if the contract is subject to the regulation, oversight, management, policy-setting or quasi-judicial authority of the boards of which you are a member. Secondly, you cannot appear before your boards (HIV/AIDS Partnership or the Model City Trust Advisory Board) on behalf of your private company. An appearance is defined as a presentation or meeting with officials/staff who have responsibilities connected to these boards. You can, however, appear before other County and municipal boards on behalf of your company.
