I do not recall seeing your previous fax. However, I do want to provide you with a timely response.

- 1) County attorneys are covered by the Truth in Government provision of the Citizens' Bill of Rights.
- 2) I can't give you a definitive answer to this question it really depends upon the situation.
- 3) Outside attorneys and law firms are not local public officials or employees. Therefore, I would conclude that they are not covered by the Citizens' Bill of Rights.
- 4) I don't believe there are any exceptions; those hired by contract are not within the definition.
