I received your request for an informal opinion regarding any limitations on a contract between Miami-Dade County and a former employee. Since this is an informal opinion, the Ethics Commission has not considered this matter. Please notify me if you want the matter placed on the Ethics Commission's agenda.

According to your letter, Miami-Dade County is seeking to enter into a contract with John Ritsema to serve as a coordinating agent on a county construction project. Ritsema served as Chief of Construction for the Public Works Department when he retired on March 31, 2004. As Chief of Construction, Ritsema was responsible for the Contracts and Specifications, Permits, Permit Inspections and Construction Contract Management Divisions.

As coordinating agent for the County, Ritsema's duties will include review of change orders, payment requests and design changes for the Naranja Lakes Redevelopment Project. The Naranja Lakes Redevelopment Project is receiving financing from Miami-Dade County.

Miami-Dade County may hire Ritsema to serve as a coordinating agent. Section 2-11.1 (q) (two-year rule) governs post-employment restrictions on county employees. The two-year rule only prohibits former employees from lobbying county agencies on behalf of a third party for two years after they leave county employment. Section 2-11.1(q)(1) provides that no person who has served as an elected county official, i.e. mayor, county commissioner, or a member of the staff of an elected county official, or as county manager, senior assistant to the county manager, department director, departmental personnel or employee shall for a period of two years after his or her county service or employment has ceased, lobby any county officer, departmental personnel or employee in connection with any judicial or other proceeding, application, RFP, RFQ, bid, request for ruling or other determination, contract, claim, controversy, charge, accusation, arrest or other particular subject matter in which Miami-Dade County or (1) one of its agencies or instrumentalities is a party or has any interest whatever, whether direct or indirect.

The two-year rule permits Ritsema to contract with Miami-Dade County to provide services. Therefore, Ritsema may serve as a coordinating agent.
