My name is Pedro "Pete" Cabrera and I am a recently elected member of the Doral Community Council 9 and work as Life & Health Insurance agent. At our next Zoning Appeals meeting on November 14, Item "F" is an application which has an "Option to Purchase predicated on the approval of the zoning request". The company with the option is Adrian Development Group, Inc. whose owner, Pedro Adrian is personal client mine. Mr. Adrian has been a cleint for 10+ years and his father and brother are also personal client. I do not have anything to directly gain from the approval or denial of this application, but because of my close business relationship with the family I wanted to know if this presents a potential conflict. During our recent orientation it was mentioned to us that sometimes the appearance of a conflict can also erode public trust. There is also one other factor regarding this application. About 6 months ago, prior to even being a candidate for the Community Council this applicant made a presentation of this project at a general meeting of a community based organization of which I am a part of. Ideas about about the project were discussed publically with about 35-40 persons in attendance. Although I a Community Council member at the time I do come to the table with prior knowledge and public input from both the applicant and the community.

I would appreciate your assistance in determining if any of these factors presents a potential conflict or violation. If so, my next questions is should I attend the meeting and leave for this application? Someone once told me that in a potential conflict of interest situation, that it is best to get a determination prior to the meeting because to leave during the meeting may in itself taint the vote becuase it may influence my fellow board members by them just knowing that I have a conflict. Should just not attend the meeting at all? I am not even sure that anything will actually be heard with the pending Omnipoint issue.
