Based on the facts you have supplied, I conclude that your outside employment activities would not violate the County Conflict of Interest and Code of Ethics Ordinance. This conclusion stems from the fact that you will not be involved in any private business activities relating to public housing or Section 8 housing and those businesses with whom you affiliate do not transact business with the Housing Agency. Finally, you will not be entering into any direct contractual relations with the Housing Agency.

Assuming you receive permission from your director, please realize that you must disclose the income you generate from these endeavors by July 1, 2005 -- for outside employment activities in 2004.

If you wish to have the this matter addressed by the full Ethics Commission, I can schedule it as an item for our February meeting. If you have any further questions, do not hesitate to contact me.
