Nice speaking with you earlier. I just faxed you two inquiries for review.

Attached, please find RQO 03-133 pertaining to the issue of gift solicitations. In addition to the two inquiries I recently faxed, I am also faxing two other opinions, since they are not available on our website as of yet.

As a general rule, there is no prohibition under the Code of Ethics for employees to solicit sponsorships and donations for County-sponsored events which support the department's education/public service mission. Therefore, gift solicitations for employee luncheons, picnics, etc... would be prohibited since those events are solely for the benefit of department personnel.

Please do not hesitate to call me should you have any additional questions once you've reviewed the opinions.
