Per our conversation, you indicated that Comcast does business with the County. Therefore, it would be impermissible under the County Conflict of Interest and Code of Ethics Ordinance for Comcast to pay for your travel-related expenses to Denver to participate in a focus group. I did suggest, however, that you might have two other options. 1) Ask the County Commissioner for a waiver or 2) Have the city of Denver cover your travel. The ordinance does not limit one government from paying travel expenses for employees of Miami-Dade County. Finally, if Comcast were to reimburse Denver for the cost of your trip, that's probably acceptable, too.

The City and County of Denver and the City of Aurora, Colorado are teaming up with Comcast to explore the potential uses of cable technologies to meet the unique needs of local communities beyond the current existing models. One of the first steps is to bring together a variety of specialists who work in or with local governments to participate in a two day workshop. These individuals were recommended by Byron West, the former president of the National Association of Telecommunications Officers and Advisors (NATOA), and the current Director of Television and Internet Services for the City and County of Denver.

The group represents television producers, regulators, technologists and members of the cable industry who will spend two days developing a model for the future as well as working through some of the technical opportunities and obstacles. The ideas that are generated will become the basis for creating a working model that will be a partnership between the two hosting cities above and Comcast.
