The Lowe Art Museum is applying for matching funds through the Cultural Facilities Program administered by the Florida Department of State. I deeply appreciate your willingness to lend your voice to help us secure critically needed funding to complete a project that will benefit our entire community. Recently, Miami residents Myrna and Sheldon Palley, alumni of the University of Miami and long-time supporters of cultural and educational programming all over Miami-Dade County, announced their intention to donate their world-renowned contemporary art glass collection to the University of Miami's Lowe Art Museum.
