The purpose of this investigation is to verify whether or not Miami Dade County .employees who have registered as County Vendors are in compliance with the provisions of opinions given by the Commission on Ethics and Public Trust.

### Investigation:

K10-078A Geraldo Villa Plant Electrician Water and Sewer Department (WASD). The applicant in this matter is Patricia Villa. Villa's father is Plant Electrician Geraldo Villa. The INQ is dated March 31, 2009.

The FAMIS indices indicate that Patricia villa's company GEPAT Construction & Engineering Corp. registered as a MD County Vendor June 2009. There is no record in FAMIS of payments to this vendor from the County. A review of Geraldo Villa's (e161216) personnel file did contain any outside employment requests.

The facts as we understand them are as follows:

- Your father, Gerardo Villa, is employed by the Miami-Dade County Water & Sewer Department as a Plant Electrician.
- GEPAT CONSTRUCTION AND ENGINEERING CORP. is a business owned partially by you and in which you serve as President.
- GEPAT CONSTRUCTION AND ENGINEERING CORP. deals in construction contracting.

It is the opinion of the Ethics Commission staff that GEPAT CONSTRUCTION AND ENGINEERING CORP. may register to contract with the County as long as any contract does not interfere with the full and faithful discharge of your father's duties to the County. This includes the condition that Gerardo Villa not participate in determining the contract requirements or in awarding the contract. Additionally, none of his job responsibilities and job descriptions may require him to be involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination, or forbearance. Finally, Gerardo Villa may not work in any County department that will enforce, oversee, or administer the contract. In other words, as long as your father is employed by the Water & Sewer Department, your company may not contract with the Water & Sewer Department.
