To review the Campaign Treasurer Reports (CTR) for the members of Community

Council Zoning Appeals Board 12 (CCZAB12) to determine if any of campaign

contributors listed on the CTR's may have some interest, (either direct or indirect) in

Zoning applications considered the members of the CCZAB.

Methodology,

- The study group consists of the elected members of CCZAB 12 for the years 2008 and 2010.
- Each CCZAB member's CTR's was reviewed. During the review, it was noted that many of the candidates self-funded their campaigns. Those CCZAB members who self-funded their campaigns were not considered.
- 3. Source of contribution.

- a. If a contribution was made by a firm, the name of the firm was listed.
- b. If the contribution was made by an individual, research was done to determine if the individual or some entity represented by the individual had a zoning application before the CCZAB.
- c. Donations not related to a. or b. were not considered.
- 4. 90 zoning applications between 2007 and 2011 were reviewed.
- 5. CCZAB12 members considered were Angela Vazquez and Jorge Garaga.

Angela Vazquez (Vazquez) The review of Vazquez's CTR's indicates that the

majority of contributions were in small amounts. The largest contribution was for

\$250 and can be attributed to an individual listed as a CPA, a second contribution for

\$100.00 was attributed to individual who listed his occupation as retired. As a result,

Vazquez was dropped from the study group.
