

In re: Crespo v. Sarnoff

C 12-41

PUBLIC REPORT AND FINAL ORDER

Al Crespo, a private citizen, filed the above-referenced complaint against City of Miami Commissioner Marc Sarnoff. The complaint alleged that respondent failed to disclose gifts of travel reimbursements related to a trip taken to Brazil in April 2012. If true, failure to disclose gifts valued at over \$100 might violate the County Ethics Code at Sec. 2-11.1 (e)(4).

The relevant facts are as follows: In anticipation of the City of Miami's involvement in a Volvo Ocean Boat Race, Commissioner Sarnoff and his wife traveled to Brazil in April 2012. For part of the time, Commissioner Sarnoff participated in official city business involving the Volvo Ocean Boat Race. At other times, he participated in functions related to supporting the Greater Miami Convention and Visitors Bureau (GMCVB), as outlined in the attached agenda.¹

Commissioner Sarnoff's travel expenses were paid in part by the Volvo Ocean Boat Race organization and the GMCVB. Relying on an opinion from the City Attorney for the City of Miami, Commissioner Sarnoff did not disclose his travel-related reimbursements paid for by these entities. Additionally, Mrs. Sarnoff's airfare expenses were paid for by the Volvo Ocean Boat Race organization, and Commissioner Sarnoff did not disclose the gift of his wife's airfare reimbursement.

http://www.miamiandbeaches.com/headerfooter/about-gmcvb/mission-statement. The Ethics Commission acknowledged that the goals of the GMCVB, a nongovernmental entity, are somewhat similar to, but not the same as, those of the City of Miami and its agencies.

Pursuant to the Code of Miami-Dade County at Sec. 2-1068, the jurisdiction of the Ethics Commission extends "to any person required to comply with the County or municipal Code of Ethics Ordinances...." The County Ethics Code at Sec. 2-11.1(a) extends the jurisdiction of the County Ethics Ordinance to municipal elected officials.

On November 27, 2012, the Ethics Commission found that the facts in this case supported a reasonable belief that the County Ethics Code might have been violated. On December 18, 2012, the Ethics Commission agreed to resolve the matter by issuing two Letters of Instruction—one addressed to the City Attorney for the City of Miami and the other addressed to Commissioner Sarnoff. On January 24, 2013, the Ethics Commission approved both Letters of Instruction. The one addressed to the City Attorney for the City of Miami stated that Commissioner Sarnoff should have disclosed travel-related reimbursement received from the Volvo Ocean Boat Race organization and the GMCVB because he engaged in some activities that were not related to conducting official city business. The Letter of Instruction addressed to Commissioner Sarnoff stated that he should have disclosed the gift of his wife's air travel provided by the Volvo Ocean Boat Race organization because the gift to his spouse, whose travel was unrelated to official city business, was a gift to the Commissioner himself.

Therefore it is:

ORDERED AND ADJUDGED THAT the complaint against Marc Sarnoff is concluded.

DONE AND ORDERED by the Miami-Dade County Commission on Ethics & Public Trust in public session on May 21, 2013.²
