Subject: INQ 18-101 Hydi Webb, Manager, Cruise Development, Port/Miami (Travel Expenses Re: Inaugural Cruise of the Norwegian Bliss)

Ms. Webb:

You have inquired on behalf of Port/Miami Director Juan Kuryla and yourself regarding whether your acceptance of the invitation from Norwegian Cruise Line (NCL), a County contractor at Port/Miami, to attend the Inaugural cruise of its new ship, *Bliss*, would be permissible under the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, specifically, Section 2-11.1(w) of the Ordinance, under which County employees and officials are prohibited from accepting, directly or indirectly, any travel or travel-related expenses from any County contractor, vendor, service provider, bidder or proposer.

The event in question will take place May 8-10, leaving from Port/Miami for a two-night cruise. The cruise is not open to the public but being conducted for NCL's senior executives, leaders from the cruise industry and the local community, including Miami-Dade County officials whose roles in the County involve them in the affairs of Port/Miami and the cruise industry. You have informed that the inaugural cruise will leave late in the afternoon of the May 8 and return in the early morning of May 10. There will be various events scheduled during the cruise, some of which would involve County officials meeting with and interacting with NCL executives and representatives. There will be a ceremony conducted at the Port itself, but most of the activity will occur during the cruise, including those that will involve County officials. Based on previous opinions, you are aware of the prohibitions under Section 2-11.1(w), and accordingly, asked NCL to provide an appropriate fee for those accepting the cruise due to their County positions. The fee, which is a standard one that is provided for public entities, such as the County, which have restrictions against the acceptance of gifts by public officials/employees from contractors doing business with those entities. NCL has indicated that the standard price provided to public officials in these situations is \$100 per person per night, which is inclusive of food, beverage and usage of ship facilities and activities. It is the intent of the Port Director to pay for his and your cruise expense from Port funds.

Based upon the circumstances noted above, it is my opinion that you and the Port Director may attend this inaugural cruise and pay the requested sum from Port funds. There is no doubt that the event in question justifies the attendance of some County officials to meet and discuss Port activity and to participate in an event such as this one, which directly relates to the promotion of Port activity and appropriate connections and interactions with executives and personnel of an important port cruise line. The payment of the suggested fee provides sufficient consideration for the cruise to avoid the prohibitions of Section 2-11.1(w). It is permissible to utilize port funds for this payment, and not a violation of

Section 2-11.1(g) of the Code (Exploitation of Official Position), due to the public purpose being served by County officials attending an event directly related to their official duties.
