## Mayor Cid:

You inquired concerning whether you would have a voting conflict under Section 2-11.1(d) of the County Code of Ethics in voting on an item coming before the Town Council, of which you are a voting member, involving an application for a Florida Department of Transportation County Incentive Grant Program in the amount of \$4,000,000, which will involve the building of a new road that will improve access to 151 Street/153 Street area. You are employed by Horizon Properties as a leasing agent, paid a salary draw plus commissions. Horizon is the leasing agent for a building in the area of which would be affected by the new road, should the grant be received. You are not the leasing agent for this building and have no financial interest in the building. Your employer, Horizon, also does not have any ownership interest in the building, but acts merely as the leasing agent, and has done so for many years.

Under these circumstances, it is my opinion that you do not have a voting conflict of interest in participating and voting on this grant application. There is no reason to expect that your employer would be measurably affected by the increased access to the building, where it is only the leasing agent for the building and has no ownership interest in it. Likewise, you would not be likely to profit or be enhanced by the vote on the grant, since you have no ownership interest in the building, nor any direct contractual or financial relationship with the owner of the building. Therefore, you may vote on it when it comes up at the meeting.
