Mr. Davis:

This is in response to your memo of 5/9/2018 regarding the Selection Committee on Project No. E-17-MDAD-04. The memo was submitted in compliance with R-449-14 to advise the Ethics Commission of potential conflicts involving County selection committee members. The memo indicates that Mr. Miguel Riera, an engineer in the Miami-Dade County Aviation Department and a voting member of the selection committee, disclosed in his neutrality/disclosure form that he was previously employed (05/96-06/97) by Milian, Swain and Associates, Inc., a respondent on the project. Mr. Riera also stated that he has no financial investments or interest in the company. I have spoken further with Mr. Riera and ascertained from him that, other than a cordial professional relationship with the company, he has no close personal friendships with individuals at the company and no other familial or other personal ties to the company. He believes that he can be completely fair in the process, and that his judgment would not be affected by his prior employment relationship with Milian.

Based on the foregoing, it is my opinion that Mr. Riera has none of the relationships with the company, nor any direct interest in the contract, that would create a voting conflict of interest for him in participating on this selection committee. In addition, the remoteness and brevity of his employment with the company, and lack of any current close relationships with individuals at the company would not, in my opinion, create any appearance of impropriety or unfairness that would undermine the public's trust in the selection committee's decision-making. I see no reason why he should not participate on this committee.
