Mr. Oporto:

You have inquired about financial disclosure of your outside employment income.

As background, you advise that you started your employment in the County in January 16, 2018, as a full-time employee working at the Miami-Dade County Aviation Department as an Engineer 3. You advise that you are engaged in outside employment. Outside employment requirements in Miami-Dade County involve a two-part process. You have already complied with the first requirement by filing an Outside Employment Request Form for 2018 and you have been granted permission to engage in outside employment. Miami-Dade Code 2-11.

The second requirement is to file an Outside Employment Statement for 2018. Given that you became subject to the County Ethics Code in 2018, pursuant to County Ethics Code Section 2-11.1(k)(2), you would file an Outside Employment Statement by noon, July 1, 2019 reporting the **annual income** you earned in Outside Employment in **2018**, and yearly thereafter as long as you are engaged in outside employment. See, RQO 13-01 (financial disclosure by July 1st following each year of service) and INQ 13-181
