#### Dear Mr. Gross,

You have inquired regarding whether a conflict of interest exists under the County Ethics Code where you the chairman of the 79th Street Corridor Community Redevelopment Agency (CRA), is also director of a non-profit that is responding to an RFP that was issued by the CRA.

#### **Background**

- You are the Chairman of the 79<sup>th</sup> Street Corridor Community Redevelopment Agency (CRA).
- You also serve as an **unpaid directo**r of the 79<sup>th</sup> Street Corridor Neighborhood Initiative (The Initiative), a 501(c)3, community based organization.
- The Initiative is separate from the CRA. Its mission is to use a Transit Oriented Development approach, along with existing community assets, to transform 79<sup>th</sup> Street Corridor neighborhoods into a community of choice for people to live, work and visit. It is led by three local community-based development organizations (the Urban League of Greater Miami, Inc., Neighborhood Housing Services of South Florida, Inc. and DEEDCO.
- The CRA issued an RFP for Economic Development Coordinator Services.
- The Initiative is a possible respondent to the RFQ.
- There is a selection committee that would evaluate the proposals, and make a recommendation to the CRA. While you are not a member of the selection committee, you are chairman of the CRA, which makes the final vote on the entity that would be awarded the contract.

#### <u>Analysis</u>

CRAs are not always considered to be County boards under the jurisdiction of the Miami-Dade Commission on Ethics. We have consulted with Assistant County Attorney, Terrence Smith, who advised that the 79<sup>th</sup> Street Corridor Community Redevelopment Agency (CRA) passed a resolution in which they adopted the Miami-Dade Conflict of Interest and Code of Ethics.

Section 2-11.1(v) of the Ethics Ordinance covers potential conflicts of interest for members of County advisory or quasi-judicial boards. The CRA is more of an autonomous board rather than an advisory board or quasi-judicial

board, but since autonomous boards do not have a separate voting conflict provision in the ordinance, we have generally applied 2-11.1(v) to such boards when a voting conflict issue arises.

Under Section 2-11.1(v), for such a board member to have a voting conflict, that member would have to be directly affected by the vote, as well as have a special relationship, such as officer or director, with the entity coming before the agency. While you are a director on the board of The Initiative, a voting conflict would occur for you at the CRA only if you were to be personally affected in a direct way by the vote. Since you are an unpaid director of The Initiative and you have no expectation that a matter will be coming before the board that directly affects you as an individual, it seems unlikely that you would have a legal voting conflict of interest on such a matter under Section 2-11.1(v) of the Ethics Code.

However, it is our understanding that, there may be other respondents to the RFP other than The Initiative. All of the potential respondents would be positioned to compete for the contract before the CRA when the time comes for it to make the final decision as to what entity to award the contract. We see the potential that the fact that you are a director on the board of one of the respondents to the RFP, could raise issues about the fairness of the process and create an appearance of impropriety, as the CRA, of which you are chairman, will have the final vote on the entity that would be awarded the contract. It is therefore our recommendation that the safest route, at this point, may be for you to consider refraining from voting on the item when it comes before the CRA for a final vote on the entity that would be awarded the contract. *See* INQ 17-69.

Additionally, you should be made aware that, under Section 2-11.1(m)(2) of the Ethics Code, you should not yourself ever appear before your own board to make a presentation on behalf of a third party. Therefore, in the event that a matter should come before the CRA in which The Initiative has an interest or is itself appearing before the CRA, you should not be involved in making any presentation on behalf of The Initiative.
