Subject: INQ 18-73 Hector Garnica, Systems Support Manager, Transportation Services Division, Information Technology Department (ITD), Miami-Dade County (Gifts)

Mr. Garnica,

You have inquired, in your capacity as Systems Support Manger in the Transportation Services Division of the Miami-Dade County Information Technology Department (ITD), regarding whether it would be permissible, under Section 2-11.1(e) of the County Ethics Code, for the County to partner with Econolite, a contractor with ITD, to share a \$10,000 fee for the marketing and equipment set-up costs in connection with a booth at the Emerge Americas 2018 Conference to be held on April 23 at the Miami-Beach Convention Center. The proposal for the joint booth sponsorship came from the Marketing Division of the Department of Transportation and Public Works (DTPW), which is the user department for the \$11 million contract for Traffic Control and Modernization Services. The Emerge conference is a premier event for showcasing new technologies. Miami-Dade County has been involved with this conference in the past, and views it as benefiting the County by showcasing its technology initiatives, in particular the Adaptive Signaling and Transit Signal Priority technology deployed by Econolite under its County contract, to a variety of technology enterprises, startups, and government leaders focused on innovative digital solutions. It is also hoped that the convention will stimulate investment in the local community by aspiring technology entrepreneurs. The fees in question would be paid directly to the convention center. Econolite, of course, would also benefit, by having its technology on display to potential purchasers of its products and services.

The contract that Econolite has with the County was awarded under a bid waiver arrangement approved by the County Commission, following a review and recommended changes by the Office of Inspector General. I have been informed that there is a follow-up contract contemplated by the County that is being prepared through County procurement officials for public bid, that will be worth much more than the current contract.

Section 2-11.1(e) of the County Ethics Code governs the solicitation and acceptance of gifts. It is an appropriate provision to consider in connection with this inquiry, due to the fact that the County has essentially solicited from Econolite a contribution toward the event that could be considered a gift to the County. There are significant restrictions on the solicitation and acceptance of gifts by County officials and employees under the Code that are get

particular scrutiny when the gift is provided by a County vendor or contractor. There is actually a complete ban on solicitation of gifts unless they fall within one of the exceptions in the ordinance. Subsection 2-11.1(e)(2)(e) does create an exception from the ordinance for "Gifts solicited by County employees or departmental personnel on behalf of the County in performance of their official duties for use solely by the County in conducting its official business." This exception could apply here, given the fact that County personnel involved with the contract have expressed that the County has participated in the convention in the past, and that the County's involvement at the convention would serve bona fide County purposes. I am concerned, however, that the benefit to the County may be exceeded by the benefit to Econolite, in that it provides to that private company a unique opportunity to market its products with a public endorsement from the County. This does not seem consistent with the concept of a gift that is used **solely** by the County, which the exception under Subsection 2-11.1(e)(2)(e) requires.

In applying Section 2-11.1(e), which has a complete ban on solicitation of gifts by County employees, as well as a prohibition on acceptance of gifts which are provided in connection with some governmental action taken or to be taken, to the facts of this inquiry, I am concerned that this joint operation, which could be construed as an advertising vehicle for Econolite, funded, in part, by the County, would violate that section. Furthermore, the possibility that it will appear to other potential County vendors, to signal an inappropriate relationship between the County and a current vendor, leads to further concerns. The importance of the appearance of complete integrity in County procurement processes is paramount in maintaining the County's reputation for integrity in its business relationships with the private sector. This particular company has already received a bid waiver on a significant County contract. It is likely to be a prime contender on an upcoming procurement for a much larger contract. It is unknown at this time whether there will be competition for that contract, or whether there may be consideration of another bid waiver. In either event, the appearance provided by the County's joint sponsorship with this private contractor of a booth that will pay part of the County's expenses as well as provide the Company with a unique opportunity to market its products under the County's seal of approval, raises concerns about whether the County's consideration of the company in connection with the upcoming procurement will be fair and objective. In the event that there are competitors for the upcoming contract, it is likely that they will be aware of the County's close association with this company at the Emerge Americas convention.

While the County may find that its interests are served by its presence at this event, I have concluded that the County's participation in the convention should occur on the County's terms at its own expense and not in partnership with a private company which has its own agenda and interests that may not always coincide with the County's interests. Therefore, it is my recommendation that the County not go forward with the joint sponsorship of a booth with Econolite at the Emerge Americas Convention.
