Mr. Rementeria,

This is in reply to your email below seeking an opinion regarding whether before the Miami-Dade County Board of County Commissioners on a matter that you have voted upon as a member of the Miami-Dade County Planning Advisory Board. You have informed me that the item in question is an application by the owner of a parcel of land that is currently approved for industrial uses to be permitted to construct 270 apartments on the site as Work Force Housing. The PAB voted in favor of the change, and it is expected to go before the BCC for its approval. You have informed that you voted against the item when it came before the PAB. The PAB does not conduct quasi-judicial hearings and the session in which you voted on this item was not a quasi-judicial hearing.

You have also informed that your sole interest in the issue is as a resident and homeowner in the area that would be immediately affected by this project, should it go forward. You are a member of the community association that has concerns over it, and you yourself would like to speak as a resident of the area and present your opinion before the BCC. You have indicated that you have no connection to applicant on the project, financial or otherwise; that you will receive no compensation from any party for your appearance before the BCC; and that you are intending to go and present your views solely as a resident of the affected area and without any use of or mention of your position with the Planning Advisory Board.

The PAB is a County Advisory Board, and you are, therefore subject to the County Ethics Ordinance, specifically, Section 2-11.1(m)(2) governing appearances before other boards. Under that section, members of advisory boards may not appear before the board of which they are a member to make a presentation on behalf of a third person or to accept compensation, directly or indirectly from a third party seeking a benefit from the board. This section would not apply to you in this situation, since you are not appearing before your own board, but before the BCC, which is a separate County board.

There is no prohibition under Section 2-11.1(m)(2) or under any other provision of the County Ethics Code that would prevent your speaking before the BCC on this matter as a citizen exercising his constitutional right to petition his government. It would not, however, be appropriate for you to make any reference to your position on the PAB, as you have no authority to speak on its behalf, and, in fact, you did not agree with the position taken by the PAB.

It is my opinion that, as long as your appearance before the BCC is limited to expressing your own interest in the item as a local resident; you are not representing any party other than yourself; you are not receiving compensation for your appearance; and you will make no reference to your position as a member of the PAB; that you may appear and speak on this issue before the BCC.
