Ms. Sears:

You inquired regarding lobbyist registration and training.

You advise that you registered as a lobbyist in Miami-Dade County in April 2018. However, you will not be able to complete the lobbyist ethics training course until June 15, more than 60 days after your registration, because the May 15 lobbyist training course provided by the Commission on Ethics is full. You would like to know if you can lobby JHS if you have not completed the training within 60 days and whether ethics courses that you have completed in your company would satisfy the lobbyist training requirement.

The Miami-Dade County Ethics Code at Section 2-11.1(s)(2)(d) requires those who register to lobby in Miami-Dade County to complete lobbyist ethics training offered by the Miami Dade County Commission on Ethics and Public Trust within 60 days of registering as a lobbyist. Lobbyists who have not completed the lobbyist ethics training provided by the Commission on Ethics within the required 60 days, may not lobby until the training has been completed. See INQ 17-289 (Lobbyist ethics course should be completed within 60 days of initial registration as a lobbyist, or must be completed prior to an individual engaging in lobbyist activities thereafter). Ethics training provided by your company to its employees does not satisfy the County Ethics Code's lobbyist training requirement.

Under certain circumstances, lobbyist training can be provided on dates other than those advertised on the Commission website. Please contact Mr. Robert Thompson, Community Outreach Coordinator, at Robert.Thompson@miamidade.gov to inquire about arranging lobbyist training on other dates.
