Re: INQ 19-05 Limitations on Transacting Business with the County

Dear Ms. Pierre-Louis:

You asked about limitations in contracting with the County through your privately-owned company, Brookridge Pointe Inc. ("Brookridge"). In your application dated <u>January 9, 2019</u>, you advised the Ethics Commission that you are a County employee, who works for the <u>Miami-Dade Communications Department ("COM")</u> as a <u>311 Senior Call Center Specialist</u>.

The County Ethics Code at Sections 2-11.1(c)(2), (d), and (g) allow you to enter into a contract, individually or through a firm, with Miami-Dade County, provided that the contract does not interfere with the full and faithful discharge of your duties to the County.

This means that you shall not participate in determining the contract requirements or in awarding the contract. Additionally, none of your job responsibilities and job descriptions shall require you to be involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination or forbearance. In your case, this means that Brookridge shall not enter into contracts with the COM Department. Furthermore, you may not use your County position to secure **special privileges or exemptions** with respect to the contract and you may not lobby the County on behalf of your business. *See* County Ethics Code §§ 2-11.1(g) and (m).

This opinion is limited to the facts as you presented them to the Commission on Ethics regarding conflicts under Subsections (c), (d), (g), and (m) of the Miami-Dade Conflict of Interest and Code of Ethics Ordinance only. Other conflicts, based on directives from your son's Department or under state law, may apply. If you have additional questions regarding possible conflicts based on Department directives, contact your Department supervisor or the Mayor's Office. Questions regarding the state ethics laws should be addressed to the State of Florida Commission on Ethics.
