In correspondence to our office on November 21, 2008, you said that a business in which you have a one-third ownership, DELTA FIVE SECURITY, LLC., is seeking SBE certification and would like to apply to the County as a vendor. You further stated that DELTA FIVE SECURITY, LLC., provides security services, and you are a Miami-Dade County Commissioner representing District 11.

It is our opinion that nothing in the County Ethics Code prevents DELTA FIVE SECURITY, LLC., from seeking SBE certification. However, the Ethics Code at §2-11.1(c)(1) prevents you as a County Commissioner from entering into a contract with the County through a business in which you or an immediate family member has a financial interest, directly or indirectly, unless you receive a waiver from the County Commission.
