Hello Eve,

I've spoken with Robert Meyers about the voting issues you described below, and we agree that the <u>a</u> <u>voting member should recuse himself</u> when voting on a matter that would affect him "in a manner distinct from the manner in which it would affect the pubic generally." Co. Code at 2-11.1 (d).

Even though these individuals will not profit from the vote, the Co. ordinance requires recusal if the voting member would be "enhanced" by the vote. We believe that the mayor and council member who are being honored by having buildings named after them are being "enhanced" by the honor.

Recusal under County law requires that the voting member <u>not vote and not participate</u> in any way. This means that each must leave the room when the discussion of his matter begins and not return until the final vote is cast.
