To answer your first question, you are required to file an Outside Employment Statement for the months in 2008 that you were employed by the City of Miami Beach and, at the same time, engaged in outside employment. Preferably, you should file the statement with the Miami Beach City Clerk within 60 days of your departure from government employment or, otherwise, at your earliest convenience before July 1, 2009.

Regarding your second question—that your previously filed Financial Statements have been removed from the Miami Beach databank—I have asked another division within our office to look into this matter.
