There is no conflict for her to remain on the Florida Housing Coalition, but a voting conflict could be created for her if matters involving Miami-Dade County OCED were to come before the Florida Housing Coalition. If this happens, she might need to recuse herself from the discussions and the vote. It depends in part on whether or not she could personally benefit from participating in or voting on these items. As far as the use of her title is concerned, it seems to me that her appointment to the Florida Housing Coalition is connected to her position in Miami-Dade County, which means it would be appropriate for her County title to be listed along with her name.
