Dear Mr. Friedman:

Robert Meyers has asked me to respond to your question about whether a Council Member in the Town of Cutler Bay may vote to appoint himself as Vice Mayor.

In brief, we find that the Miami-Dade County Ethics Code at Sec. 2-11.1 (d) allows the Council Member to vote on his own appointment because the Town Council is the sole entity charged with the duty to vote to appoint its Vice Mayor.

We are also persuaded that the Council Member would not profit distinctly by the vote since compensation for the Vice Mayor's position is no different than compensation for the position of Council Member.

Although the County Code does not require recusal in this instance, the Council Member may choose to recuse himself if he believes his vote would create an appearance of impropriety.


