Limitations on Doing Business with the County

Dear Ms. Thomas:

In correspondence to our office on August 23, 2010, you said that you wish to do business with the County through your privately owned unincorporated business, SHEER PURRFECTION PUBLISHER.


IT IS THE OPINION of the Ethics Commission staff that SHEER PURRFECTION PUBLISHER may enter into contracts with the County, but not with the Miami-Dade County Police Department because of the employment of your spouse, Frederick Alan Thomas, with the Police Department.

THE FACTS as you presented them are that SHEER PURRFECTION PUBLISHER is a publishing business owned by you. Your spouse, Frederick Alan Thomas, is employed by the Miami-Dade Police Department as a Police Officer.

THE COUNTY CODE allows you and/or your company to enter into a contract with Miami-Dade County as long as the contract does not interfere with the full and faithful discharge of Officer Thomas's duties to the County. This includes the condition that Officer Thomas not participate in determining the contract requirements or in awarding the contract. Additionally, none of Officer Thomas's job responsibilities and job descriptions may require him to be involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination, or forbearance. Finally, Frederick Alan Thomas may not work in any County department that will enforce, oversee, or administer your contract.


