# Chief Fernandez.

In our discussion today, you stated that you would not be engaging in outside employment as a healthcare liaison with North Shore Medical Center. You recognized that functioning as a spokesperson for North Shore Medical Center on health-related issues and, at the same time, serving the community as a Miami-Dade firefighter could create, at a minimum, an appearance of impropriety.

We agreed that firefighters carry out many duties, including the responsibility to educate the public on health and safety matters. The Ethics Commission has found that outside employment conflicts with government employment when the two pursuits overlap or are closely related. *See* County Code at Sec. 2-11.1 (j) and RQO 12-11.

I have placed your resignation letter to North Shore Medical Center in your file. Thank you for your diligence in resolving your ethical query.

In my position as a Chief Fire Officer, I serve as an operational Battalion Chief and my job description is located in the Miami-Dade County personnel web page as; "Chief Fire Officer." There you will find the official job description and the duties I am responsible for.

As a Community Healthcare Liaison for North Shore Medical, my job description is to interact with the community and provide health care information.
