Ms. Madison,

As we discussed today, nothing in the ethics code prohibits Director Copeland from attending a cocktail party at the invitation of Catholic Hospice to learn more about Camp Erin—a bereavement program for children who have experienced the death of someone close to them.

Among its many services, the Juvenile Services Department (JSD) may have occasion to recommend bereavement counseling to at-risk youth and youth involved with the Juvenile Justice System.

In its efforts to influence an official action by Director Copeland, however, state law prohibits lobbyists from giving gifts to the Director in excess of \$100 per year.
