Commissioner Bovo's staff member called regarding the Commissioner's soliciting contributions to the YMCA. He intended to send a letter to potential contributors praising the YMCA and inviting them to meet personally with him. These meetings were to be held for the purpose of soliciting donations. The aide indicated that a number of the potential donors were county contractors or vendors or persons having pending issues in the county. I advised that, pursuant to Secton 2-11.1 (e)(2)(g) a County Commissioner is permitted to solicit on behalf of a 501(c)(3) organization. However, I cautioned that such solicitations should be limited to general solicitations rather than invitations targeted to specific individuals, particularly ones with pending county business. I advised against his meeting personally with a county contractor to make such a solicitation.
