Based on the facts you presented, I strongly recommend that Ms. Oca register as a lobbyist before you speak to her.

Although you say you are gathering information only, it appears likely that Ms. Oca may seek another city contract in the foreseeable future because of her unique knowledge of swimming pool design.

Consequently, Ms. Oca should register as a lobbyist before you knock on her door. This provides transparency to the conversation, in the event that your discussion moves from strictly informational to persuasive. Once Ms. Oca <u>attempts to influence your official decision-making process in any way, she is a lobbyist</u>.

It is a violation of the ethics code to attempt to influence an official decision without registering as a lobbyist. There are often no bright-line distinctions in these matters. That is why I urge you to proceed cautiously so that you do not create an ethical problem for Ms. Oca and yourself.

Although you may have knocked on a person's door as a private citizen without giving it a second thought, you must proceed differently as an elected official.

Hello Commissioner Welsh,

You asked if you may meet with Miren Oca, a city contractor who you say has broken off discussions with the city. I assume this means that Ms. Oca has severed her contract with the city, is not now bidding on a contract, and will not in the near future bid or rebid on a city contract.

Under these circumstances, you may meet with Ms. Oca as long as Ms. Oca does not have a bid that is currently being evaluated by the city, your meeting is strictly informational, and she is not attempting to influence you to take any official action.

If Ms. Oca attempts to persuade you that the city should use her services now or in the near future, she is lobbying and, consequently, she must register as a lobbyist in the city and you have a duty to confirm that she has registered. The city's lobbyist ordinance can be found at Chapter 8A-5 of the City of South Miami Code of Ethics.
