Ms. Millan and Mr. Shortal:

You asked if the Ethics Code prevents Mr. Shortal from serving on the above-referenced selection committee.

The selection committee is reviewing four proposals—one of which is from AECOM Technical Services, Inc. Mr. Shortal was employed by AECOM Technical Services, Inc., in its transportation "business line," until April 2, 2010. His appointment to the selection committee occurred on March 1, 2012, at which time he immediately began performing official duties in this capacity.

Sec. 2-11.1 (x) of the County Ethics Code prevents Mr. Shortal from performing any County contractrelated duties regarding AECOM Technical Services, Inc., for two years following his employment with AECOM. Consequently, **Mr. Shortal should not be serving on the selection committee described above because he was appointed and began his official duties prior to the two-year ban.**

We further advise that an appointment to a selection committee shortly after the two-year proscription, although not strictly prohibited by the Ethics Code, may create an appearance of impropriety.

Various "business lines" and FEINs at AECOM Technical Services, Inc., are not factors distinguished in the Code and are not relevant to this opinion.

The foregoing construes the Miami-Dade County Ethics Code only and is not applicable to conflicts under other County or state laws.
