Ms. Lighterman,

As an addendum to the previous opinion given to you, please note that <u>a board member cannot enter into</u> <u>a contract with the board on which he serves</u>. *See* County Code at Sec. 2-11.1 (c)(3).

Although you did not state whether Mr. Edwards had entered into a contract with the Film and Entertainment Board, it appears that, minimally, an oral agreement may have been made in violation of the County Ethics Code.

Accordingly, the Film and Entertainment Board cannot contract with one of its board members to use the venue of the board member.

Ms. Lighterman,

You asked if Will Edwards, a Film and Entertainment Board member, may host Film and Entertainment Board events at a nightclub he owns when he will receive a portion of the money raised at the events. We discourage the arrangement based on the recurring appearance of impropriety that is created.

However, if the Film and Entertainment Board wishes to use the venue of a board member, several sections of the County Ethics Code regulate the board member's actions:

First, the board member must *not* take any official actions when his financial interests will be affected, directly or indirectly. *See* County Code at Sec. 2-11.1 (n).

Second, the board member must not seek any benefit from the Film and Entertainment Board on behalf of the nightclub he owns and/or is employed by. Consequently, he must not appear before his own Board to

promote the nightclub as a venue for Board events if he will benefit from the arrangement. *See* County Code at Sec. 2-11.1 (m)(2).

Third, the County Code specifically prohibits the board member from voting on, or participating in, matters before the Film and Entertainment Board if the board member will be directly affect by the action of the Board *and* he has a business relationship with the entity under discussion. Prohibited business relationships in this case would include officer, director, partner, consultant, employee, stockholder, debtor, or creditor. *See* County Code at Sec. 2-11.1 (v) for the complete list of prohibited relationships.

Based on the foregoing, each time an issue involving Mr. Edwards' venue comes before the Board, Mr. Edwards must leave the room to avoid participating in, discussing, or voting. Within 15 days of the voting conflict, Mr. Edwards must disclose the conflict by filing State Form 8B with the person who keeps minutes for the Board.

Please note that local board members are also subject to the State Ethics Code, which is interpreted by the Florida Commission on Ethics (<u>http://www.ethics.state.fl.us</u>).
