The County Ethics Code does not prohibit you, as a training and certification officer with the County Department of Regulatory and Economic Resources, from serving as a member of the Broward Board of Rules and Appeals in a volunteer capacity.

Sec. 2-11.1 (j) of the County Ethics Code prohibits County employees from engaging in certain activities that would impair their independence of judgment in the performance of their public duties to the County.

We concur with your supervisor and department director that you are unlikely to be confronted with issues on the Broward Board of Rules and Appeals that would impair your judgment or divide your loyalties as a County training and certification officer.
