Generally speaking, it is permissible under the Sunshine Law to place matters such as these in a memo that is circulated among all other members of the board, and made a public records by the Clerk. It is also advisable that the Clerk, rather than you, be the one to distribute it and that it specifically warn against any other board member responding to it (as you apparently already do). Dear All:

At times I email the Town Manager, Town Attorney, Town Clerk and the Elected Officials regarding some clerical matter (emailing all at the same time). As an example, we (elected officials) submit discussion items to be placed on the upcoming monthly Commission Meeting. I have attached this for you to see. I also put this on the email as a reminder:

## ELECTED OFFICIALS PLEASE DO NOT RESPOND TO ME OR TO ONE ANOTHER REGARDING THIS CLERICAL MATTER – ONLY COMMUNICATE TO NON-ELCETED TOWN OFFICIALS (STAFF) – AND/OR WAIT UNTIL A COMMISSION MEETING TO DISCUSS - AS COMMUNICATING ABOUT THIS COULD BE A VIOLATION OF SUNSHINE LAWS.

I include elected officials to ensure that all are aware of the Agenda Discussion Item being submitted, allow time for thought, and to permit 'us' the additional opportunity to discuss item with (residents) constituents.

Here in Surfside, we are basically one dollar per year volunteers – recognizing of course that we are Elected Officials. I do not wish or want to get any of us in trouble.

Question: Is it 'ok' to email all a clerical matter(s)...newspaper article, agenda item (see above).

Please note that the Town Attorney's office was recently vacated; and that is why you do not see her being copied. However, I have copied the Interim Town Attorney and her Assistant.

Thank you for your help, guidance, and consideration.
