Ms. Collins,

Mr. Steinback has asked me to respond to your question about lobbying as an unpaid volunteer on behalf of the Lotus House Women's Shelter, a 501(c)(3) nonprofit charitable organization.

The County Code at Sec. 2-11.1 (s)(4) specifically excludes you from *paying* the lobbyist registration fee if you advocate for a nonprofit and are not compensated for the appearance.

Under these circumstances, however, you nevertheless *must register* to lobby the County and take the four-hour County lobbyist ethics course within 60 days of registering. The cost of the course is \$100 for all entities, including nonprofits. *See* Sec. 2-11.1 (s)(2)(d).

Dear Constance Collins,

Section 2-11.1 (s)(2)(d) of the County Code requires each lobbyist to submit a certificate of completion of an ethics course approved by the Miami-Dade Commission on Ethics and Public Trust (COE) to the Clerk of the Board within 60 days after registration, unless they have taken the course within two years prior to registration.

The COE is currently reviewing all persons currently registered as lobbyists in Miami-Dade County to determine if this requirement has been satisfied. Our initial review has indicated that you have not completed the course requirement. Failure to complete this course can result in suspension of your county lobbying privileges.

We request that you do one of the following in the next 10 days:

v Use the attached form to sign up for an upcoming COE Ethics Training Class on July 16 (video) or August 15 (live class).

v If you have taken the COE Ethics Training Class within the last two years and you believe our initial review of your status is in error, please e-mail Rodzandra Sanchez, rodzand@miamidade.gov to help us correct the record of your attendance.

V It has been the general practice of this office to accept the City of Miami's Ethics Training Course, offered by Florida International University, as satisfaction of the course requirement. If you have taken that course within the last two years, please e-mail a copy of your certificate of completion, or other proof that you have done so, to Rodzandra Sanchez, <u>rodzand@miamidade.gov</u>. It is incumbent upon those who choose this option to contact the COE office with proof of having completed that course.

v If you have registered as a lobbyist but no longer wish to maintain your registration, please e-mail Rodzandra Sanchez, <u>rodzand@miamidade.gov</u> and also Miami-Dade lobbyist registrar Claude Francis, <u>CMF@miamidade.gov</u>, indicating your change in status.
